She also represented state agencies including the Department of Services for Children, Youth and their Families.

  - o Future meeting topics and speakers discussed
  - o Board membership positions and the need for new elections discussed.
- Speaker: Krista Griffith, Delaware House of Representatives, District 12.
  - o Ms. Griffith presented the history and status of the Electric Vehicle Legislation (House Bill 177).
  - The bill passed the House and was then presented to the Senate at the 11<sup>th</sup> hour 11:49pm on June 30.
  - o Senate Republicans worried that the state was interfering with private industry.
    - Attempted to clarify that the state was only looking to charge for a service it was already providing to recoup costs.
    - Attempted to clarify the distinction in use and availability of rapid chargers vs slow chargers.
    - State chargers would only be on state property, i.e. places of employment, state parks, etc., not at gas stations or other commercial entities.
  - o Susan Love, Administrator of the Climate and Sustainability Section, Delaware Department of Natural Resources and Environmental Control
    - Discussed more details regarding electric vehicle availability and charging availability
    - Delaware losing electric vehicle sales because we have not signed the MOU
