## CONTEST RULES

### RULES

1. The DSBA Baking Contest is open to all DSBA members and their staff and family, and non-DSBA Bar members.
2. Entries must be turned in at the contest site (DSBA, 405 N. King Street, Suite 100, Wilmington, DE) between 11:30 a.m. and 12:30 p.m. on the day of the event. Entries will be judged from 1:00 p.m. to 2:00 p.m. Winners will be announced at approximately 2:30 p.m.
3. An entry form must be completed for EACH entry with accompanying entry fee. Limit two entries per category.
4. Entries must be baked and prepared at home and brought to the venue.
5. A recipe or complete list of ingredients must be included with each entry (for allergy and safety purposes). If the recipe is not your own, please reference the source.
6. Provide one cake or twelve cupcakes, one 8" - 10" pie or tart, or twelve cookies or bars per entry for judging and tasting.
7. Each entry must be homemade. You may not use store-bought cake mixes, icing/frosting, pie fillings, or crusts.
8. All entries become the property of DSBA and portions not used for judging may be used for tasting as part of the day's events.
9. Entries must be delivered in disposable or non-returnable plates or pans. Please have baked items in bakery box or appropriate container to keep fresh while waiting for judging.
10. By entering, you give permission to have your photo taken and published in all media outlets for promotion of this event.

### JUDGING

- Entries will be judged on flavor, texture, doneness and overall appearance.
- For pies and tarts, criteria includes crust color, texture, and flavor.
- Each judge assigns a numerical value (1-10) without consultation of the other judges.
- The entry receiving the highest total numerical value is the winner in that category.
- The decision of the judge is final. Judges will not know the participants names.
- Participants must be present during the contest and judging.
- Awards will be presented to the first place winner and runner-up in each category in both the Junior and Adult divisions.
